3 The Performance of the Supervision Activities

The supervision activities are performed according to the procedure "Packer licensing", code AA-00, which was made available to the LICENSE HOLDER.

4 The Obligations of the Parties

- 4.1 RAR-OCP is bound:
- to comply with the requirements provided for in the procedure "Packer licensing", code AA-00, in performing the LICENSE HOLDER supervision activities, scheduled and/or non-scheduled;
- to send the Supervision Plan to the LICENSE HOLDER:
- to publish, periodically, the suspended license list / withdrawn license list;
- to keep the confidentiality of the information obtained during the supervision activities, concerning the product, the partitioning and packing activity and the LICENSE HOLDER;
- to send to the LICENSE HOLDER the expense estimates afferent to the supervision activities;
- to notify the amendments of the RAR-OCP documentation valid during the licensing period.

4.2 The LICENSE HOLDER is bound:

- to pay, in advance, the expense estimates sent by RAR-OCP for the supervision activities, under the penalty of suspending the license;
- to bear the accommodation expenses for the supervision process activities which require the RAR-OCP representatives to travel in Romania;
- to bear the accommodation and transport expenses for the activities of the supervision process which require the RAR-OCP representatives to travel abroad.

- to allow the unconditioned access of the RAR-OCP representatives, during the scheduled or unexpected supervision activities, in all the locations where the activities afferent to the partitioning and packing activity which is subject to the license are performed;
- to notify the own marketing/outlet points;
- to insure, upon the RAR-OCP request, the transport of the taken samples;
- to formulate claims regarding the licensing, concerning only the scope for which it was granted;
- to inform the RAR-OCP of the changes it intends to perform on the partitioning and packing activity, on the holder structure or management changes, if relevant, as well as on any aspects which can influence the product conformity;
- to not provide products partitioned and packed as a result of the announced changes, without a prior agreement from the RAR-OCP;
- to keep and make available for the RAR-OCP, upon request, the records of all the claims regarding the product conformity with the requirements of the reference normative documents and the records regarding the actions taken for settling the claims and any product deficiencies;
- any reference to the license must be made only for the licensed products, without ambiguities or possibilities of confusion with other products;
- to not make any reference to the license, in the case of license suspension or withdrawal.

5 Final provisions

This convention is valid for the validity period of the License no.

The convention can be terminated unilaterally by R.A.R.-OCP, without the intervention of the courts of law and without sending any notification, upon the LICENSE HOLDER's failure to meet the undertaken obligations.
